ENGLISH STATUTES IN FORCE IN ALBERTA

INTRODUCTION

The North-West Territories Act, 49 Vict. 25, s. 3 (Can.) at the time of the Alberta Act, 4-5 Ed. 7, c. 3, s. 16 (Can.) reads as follows:

"Subject to the provisions of this Act the law of England relating to civil and criminal matters, as the same existed on the fifteenth day of July, in the year of our Lord one thousand eight hundred and seventy, shall be in force in the Territories, in so far as the same are applicable to the Territories, and in so far as the same have not been, or are not hereafter, repealed, altered, varied, modified, or affected by any Act of the Parliament of the United Kingdom applicable to the Territories, or of the Parliament of Canada, or by any ordinance of the Lieutenant-Governor in Council, or of the Legislative Assembly."

While this provision will be referred to at greater length below, it is possible to say here that it was sufficient to introduce into Alberta the statute as well as the common law of England, unless it was not "applicable" or had been changed by proper statutory authority.

Some of these statutes are well known to be in force in Alberta; the Statute of Frauds is an example. Many others, however, are not known to be in force, and, indeed, are not known at all to the public and to most lawyers. Even if a statute is known to be in existence and in force it is not always easy for the public or the lawyer to find a complete and authoritative text; here, too, the Statute of Frauds is an example. This report is intended to furnish the public and lawyers with a list of English and United Kingdom statutes which may be in force, and to provide the text of

those which are most likely to be used. We do not go on to make recommendations for the repeal or the re-enactment in Alberta of English statutes, though a study leading to such recommendations would be useful.

It is necessary to emphasize that not all the statutes listed in this report are in force in Alberta today, and that it is possible that the court may hold an unlisted statute to be in force. The question whether or not a given statute is in force is one on which different opinions may be held and which may require a lawsuit to determine. rule which has been applied is that if a statute appears to have been in force in England on July 15, 1870, according to the Queen's Printer's Chronological Table and Index to the Statutes in Force (London, 1870), and if there appears to be a reasonable possibility that a court would hold that it satisfies the other criteria contained in the section quoted above or that it was in force in Alberta of its own force, it has been included in the list. Notwithstanding these cautionary statements we believe that the list, together with its indices, will be a useful tool for those who need to find the statute law applicable to Alberta.

While we will enter upon a brief discussion of the subject, we refer the reader to two articles by Mr. J.E. Cote, upon whose research this report is based. They appear respectively at (1964) 3 Alberta Law Review 262 and (1977) 15 Alberta Law Review 29. Each contains a useful discussion of the subject. The former also contains a list of judicial decisions declaring statutes to be in force or not to be in force in some part of Canada, and the latter in summary form sets out the manner and the date as of which English law has been received elsewhere.

RULES GOVERNING THE LEGAL APPLICABILITY OF ENGLISH STATUTES

1. Statutes in force proprio vigore

Some Imperial statutes apply to Alberta because the Imperial Parliament enacted them for the territories subject to its lawmaking powers. The British North America Acts and the Statute of Westminster are obvious examples. These statutes do not depend upon the section in the North-West Territories Act for their force in Alberta; they are in force in Alberta whether or not a court would not otherwise hold them to be "applicable" within the meaning of the section. There can be questions of construction: the courts have long tended to hold that Acts of the English and United Kingdom Parliaments do not apply to colonies unless expressly made applicable, but that rule of construction did not always exist, and the intention of an earlier statute on this point may be obscure.

Statutes of this kind are said to be in force "proprio vigore," or "of their own force." They are included in the list attached only if they were enacted before July 15, 1870.

2. Statutes received as part of the law of England

(a) Historical background

The charter of the Hudson's Bay Company granted to the company governmental powers over Rupert's Land, which included most of the prairies, and thereby established English law in the area. Further, the prairie region has been treated as acquired by settlement, and English law deems that settlers bring with them to a colony acquired by

settlement so much of their own laws as is reasonably applicable to the circumstances of the new colony. The possible claims of the law of France, Quebec, and Upper Canada to be the law of the prairie region appears to have been ignored, in favour of those of the law of England. In order to end uncertainty, Manitoba and Dominion legislation adopted as the reception date of English law in Manitoba the date of the admission of Manitoba into Confederation, which was July 15, 1870, and the same date was later chosen for the North-West Territories by its Legislative Assembly and then by the Parliament of Canada through the section in the North-West Territories Act which has been quoted and which codifies the common law rule.

(b) When an English statute is "applicable"

It appears that a statute in force in England on July 15, 1870, may be "applicable" to Alberta even though in its terms its application is restricted to England. If the word where it first appears in the section meant that an English statute is in force only if its wording made it applicable, the section would be futile because it would cover only statutes which were already in force without the section; but it is clear that what is intended is to introduce English law as the foundation of the law of the North-West Territories. The terms must refer to the word "applicable" as used by Blackstone, (1 Bl. Comm. 107, as reproduced at (1977) 15 Alta. Law Review 66):

"Such colonists carry with them only so much of the English law as is applicable to their own situation and the condition of an infant colony."

or as corrected to allow for changes in the colony's circumstances to attract statutes which were not suitable for it in its infant stage.

To what circumstances is the test of applicability to be applied: the circumstances of the time of the enactment of the English statute in question, the circumstances of 1870, the circumstances of the time when the North-West Territories Act came into force, the time of first consideration of the statute by an Alberta court, or the circumstances of the present time? That question has not received an authoritative answer with regard to the circumstances obtaining in Alberta. The answer is probably, but not certainly, either July 15, 1870, or the present. The former would have the disadvantage of bringing in only the comparatively small body of law suitable to a new colony; the latter would have the disadvantage of bringing in or terminating statutes unsuspected by the public and a competent legislature. The question also has not received a definitive answer with regard to the circumstances in England which should be taken into consideration. Here it seems likely that the time will either be July 15, 1870, or the date on which the English statute comes into effect. The Alberta decisions favour the latter, but the point can still be debated.

How will the test be applied? That question adds great additional uncertainty. To show the difficulties, we reproduce here the following principles set forth at (1964) 3 Alberta Law Review 272-273 (though not the accompanying authorities):

- 1. Statutes are less likely to be found applicable than are common law rules.⁵⁶
- 2. A statute may be applicable only in part.57

- 3. A statute or rule will, however, be in force throughout the entire province, or not at all, and so the question is whether it is applicable to all, or substantially all, of the province.⁵⁵
- 4. A statute or rule fundamentally necessary to the carrying on of business and the administration of justice as now practised, is in force.⁵⁹
- 5. A statute or rule recognized expressly or impliedly by the local legislature to be in force is in force.⁶⁰

- 6. It is a strong indication of applicability that the local courts have impliedly recognized the rule or statute as being in force, over a long period of time.⁶¹
- 7. A statute or rule is not in force which was originally intended to apply only to one part of England, or to only one particular institution in England.⁶² But it should make no difference that the statute was passed only for England and had no force proprio vigore outside England.
- 8. A statute ameliorating the rigors or injustice or unsuitability of the common law, or simplifying procedure, will probably be in force.
- 9. A statute curtailing the royal prerogative will probably be in force.
- A statute in favor of the liberty of the subject will probably be in force.⁶⁵
- 11. Applicability may refer to the physical conditions and climate. or to the social conditions and public beliefs, or customs and practice of the province.
- 12. In the absence of such a difference in conditions or attitudes between England and the province a rule or statute, it is suggested. Will not be inapplicable merely because it has been criticized by English judges as being unjust or unwise, for this would be to usurp the function of the legislature. Sed quaere.
- 13. A rule or statute will not of course be in force if it is in fact incapable of being applied in the province for want of persons or things to which it could apply or institutions in which it could be applied. But this rule must be subject to the caveat that mere apparent lack of powers or jurisdiction in any provincial court to enforce or apply the rule or statute will not be sufficient for this purpose, for the provincial superior courts are presumed to have all jurisdiction except that which is expressly denied them, and as soon as an institution to which the English law could apply is established, the law becomes applicable.
- 14. A rule or statute will not be in force where its application in the province would result in far more expense and inconvenience, or injustice, than in England. This is seen in the fact that native marriages have been held valid without the offices of a clergyman contrary to the rule in R. v. Millis, to where the majority of the natives were not Christians, and priests were few and far distant.
- 15. Laws enacting police regulations are probably not in force.
- 16. Revenue laws are almost certainly not in force.⁵³
- 17. Laws for the establishment of the Church of England and the regulation of worship are probably not in force.²⁹

(c) When an English statute has become inapplicable

An English statute does not cease to be in force in Alberta merely because it has ceased to exist in England. Since the Statute of Westminster (other than some constitutional statutes) passed by the Parliament of the United Kindom, including a repealing statute, has any effect in Alberta, and

even before that the repeal would not make it effective in Alberta in the absence of a specific provision making it so.

It may now be said that the Legislature has power to amend or abrogate for Alberta any English statute which deals with a matter within the legislative jurisdiction of the province. The Parliament of Canada has the same power over English statute which deals with a matter within Parliament's legislative jurisdiction. With regard to English statutes received as part of the law of England, Parliament has had that power since it acquired jurisdiction over the west and the Legislature and its predecessor has had it at least since the enactment of the North-West Territories Act. With regard to statutes in force by their own force, they have had the power since the Statute of Westminster.

If the intent to amend or abrogate is clear, and if the amending or abrogating body has power to do so, it is easy to find that the English statute has, for the jurisdiction in question, been amended or abrogated, and similarly if the local statute deals with the same subject matter as the English statute. To the extent that the legislation is inconsistent, the English statute ceases to have effect, and also to the extent that the local statute copies the English statute without expressly preserving it. Serious problems of interpretation can arise, however, in cases of less than complete overlap between the local statute and the English statute, and the result in a particular case may well be in doubt. An English statute, therefore, should not be accepted as being in force until the statute law of Parliament or the Legislature, or both, depending upon the subject-matter, has been ascertained and its effect considered.

A further problem may arise if inconsistent federal or provincial legislation which abrogated an English statute is later repealed. It is not clear whether or not the repeal revives the English statute, and there is authority to suggest that in the case of anything less than express repeal (i.e., repeal by implication or overlap), the English statute is revived.

III CONCLUSION

Our hope is that the list attached to this report will enable lawyers, the Legislature and others to find that portion of the law of Alberta which is contained in statutes which were in force in England on July 15, 1870. We hope that we have made it clear that, having found a statute in the list, the researcher's task is by no means complete, and that he must still consider whether the statute was ever in force in Alberta, and whether it has been abrogated or amended.

ENGLISH STATUTES IN FORCE IN ALBERTA

INTRODUCTION

We have been asked by the Institute to prepare a list of the English statutes which probably are in force in Alberta today as part of the law of England adopted by the law of Alberta. The general problem is described in the memo to the Institute of Law Research and Reform attached to Mr. Hurlburt's letter of October 31, 1968. We have not felt that Imperial statutes in force of their own power (and not as English law of July 15, 1870), such as the Statute of Westminster, or the Imperial Shipping Acts, were part of our task.

Because of the existence of Her Majesty's Stationery Office's published chronological list and index to the statutes in force 1870 there is little difficulty in arriving at a complete list of the statutes in force in England on the 15th of July, 1870, or in arriving at a subject index to those statutes. The Stationery Office's list only omits a dozen or so statutes which were passed between the cut-off date of that list and the 15th of July in the same year. Nor is there any particular problem in arriving at a fairly complete list of English statutes which have been held to be in force and not to be in force by the Courts of various Commonwealth countries other than the United Kingdom. us prepared such a list sometime ago and it is over 200 pages in length.

Neither of these lists is completely satisfactory for the practitioner, however. The latter list includes a number of statutes which were repealed before the 15th of July, 1870, and omits a good many statutes which must be of practical importance but happen not to have been considered by the courts. The former is far too allembracing as it omits nothing. Yet many of the statutes which were in force in England on the 15th of July, 1870, were of little significance in England and probably of none whatever outside England. For one thing the process of pruning the deadwood out of the English statute books by means of Law Revision Acts was only in its early stages in 1870. What is far more important the law which is in force in Alberta is only so much of the law of England on the 15th of July, 1870, (a) as applicable to Alberta, and (b) as not repealed or modified by subsequent Canadian or provincial statutes. The precise meaning of these two terms is a very involved question (which one of us has discussed at some length in an unpublished monograph) but the general import of it is easy enough to see.

Therefore, the task has been to prepare a useful list of only such of the 15th of July, 1870, statutes as really appear still to be likely to have some practical effect in Alberta at the present time.

The two of us (with the assistance of Glen Acorn in the early stages) started work upon a preliminary list which one of us drew up some time ago. This latter list omitted categories of statutes which obviously were not applicable to Alberta, such as local or personal statutes

(many of which were passed under the nominal guise of public general statutes), revenue statutes, annual Militia Acts, and that sort of thing. In addition, in an intermediate stage, one of us pruned away a number of other old statutes which appeared clearly to be of no present significance. Both of us then considered each statute which remained and left it on the list only if it appeared likely to have some practical effect at the present day, and also did not appear (so far as we were able to discover) to have been replaced or repealed by Canadian or Alberta legislation. In searching for local repeal or amendment we were assisted by several law students doing summer work for the Institute.

The volume of statutes considered was very large and therefore often we were forced to consider a statute as a whole rather than considering each individual section separately. Where a statute has been included in the list as being probably applicable there are almost certainly individual sections in it which would not be applicable. On the other hand, where a statute appeared on the whole to be inapplicable we have felt reasonably safe in excluding it on the supposition that an individual isolated provision in it was likely to fall because of its general context and not to be applicable here. (There is authority in the cases for such an approach.) cases we have, however, picked out isolated provisions which appeared as though they might be in force because they dealt with a topic distinct from that of the sections which surrounded them.

The knowledge of English law required to do a perfect job in this field would be limitless, and it is entirely possible that we have omitted from the list some statutes whose provisions we did not fully understand and whose significance therefore escaped us. For this reason we would be hesitant to recommend any form of blanket repeal of statutes not included in our list. In any event, such repeal would almost certainly require cooperation of Parliament as well as the provincial legislature and that would probably be impractical. Then again, if the statutes not included in our list really are inapplicable (as we believe) their existence without repeal is probably harmless to anyone. Until now their prime significance has been as a source of worry and possible overlooked law, and we trust that making available a list of statutes which we think may have some practical effect will largely remove this fear.

On the other hand, we must not be thought to warrant the usefulness of all the statutes which we have included. We have sometimes erred on the cautious side in including a statute, and at other times have included a statute simply because we believed that it had a fundamental or theoretical significance for basic underlying rules of law which everyone takes for granted and assumes to be part of the common law. Then again, on other occasions we have included a statute because some court had held it to be in force in some jurisdiction outside the United Kingdom even though we may have had considerable doubts as to its effect. On other occasions the statute may have been on a subject covered in part by local Canadian or provincial legislation so

that it would be arguable that the field was now occupied, and the English statute by implication repealed, but we have nevertheless left it in lest we should we wrong in this feeling.

We would therefore respectfully suggest that in lieu of any statutory action being taken, the chronological list of statutes we have thus pruned be made available to the public. This might be done through a supplement or addendum to the Revised Statutes of Alberta, 1970. The alphabetical subject index put out by Her Majesty's Stationery Office in 1870 could be appended, possibly with the deletion of certain subject headings which are plainly inapplicable (such as Ecclesiastical The scope of that subject index would thus be wider than our list of statutes which we considered more likely to be in force but there would be no harm in that as it would be a double check on our work. We would also recommend that some of the English statutes which are almost certain to have a practical significance be reprinted in full or in part. An obvious example of this would be the Statute of Frauds, which is one of the most fundamental statutes for everyday practice and yet (since its virtual repeal in England in recent years) one whose text is hard to obtain, especially for a practitioner who does not have recourse to a large law library. How many of the statutes should be thus reprinted and how much of each should be reprinted is obviously a question of degree, and we think it really depends upon who is doing the publishing and how much. space and money is available. It also depends upon how widely circulated the publication is. If the report or

extracts from it were to go to the profession in the form of an appendix to the Revised Statutes of Alberta, 1970, there would be some point in such a reprint of statutes otherwise usually inaccessible. On the other hand, if the report were merely to be made available to interested parties by the Institute of Law Research and Reform, it probably would not be widely consulted by persons who did not have access to large libraries and therefore such a reprinting might well be a waste of time and money. In any event, we have given some suggestions for reprinting on our list.

We have supplied to the Institute some brief notes of our reasons for including or excluding some of the statutes which we considered in the later stages. It did not seem worthwhile reproducing these reasons for general circulation, and therefore the list of applicable statutes which we have provided is simply a summary describing each statute by its regnal year and chapter, and short title or brief description of subject matter.
